### Víctor Aparicio Basauri

Psychiatrist, MD, PhD. Trained at the psychiatric hospitals of Salt (Girona) and Valladolid, as well as at the Professional School of Psychiatry in Barcelona. Psychoanalysis with Marta Lázaro. Professor of Community and Preventive Psychology (University of the Basque Country). Professor of Psychiatry (University of Oviedo). Visiting professor at the University of Cambridge (United Kingdom). Research stays in Paris, Lyon, Ghent, and

Geneva. Former Director of the Psychiatric Hospital of Oviedo. Former Regional Director of Mental Health in Asturias. Former Mental Health Advisor for the PAHO/WHO in Central America, the Latin Caribbean, and Mexico. Humanitarian emergency missions with WHO in Haiti, Mexico, Guinea Conakry, Kosovo, Colombia, and Honduras.

### **Thomas Bignal**

Secretary General of EASPD (European Association of Service Providers for Persons with Disabilities), the largest European NGO active in the field of disability services, bringing together over 20,000 organisations from more than 40 countries. Thomas Bignal is also Vice President of Social Services in Europe and has served as Director of the Federation of European Social Employers. Master's degree in International Law.





### Naomi Brickel

Director of the Supported Decision-Making New York (SDMNY) project at Hunter College CUNY, where she leads New York's efforts to develop infrastructure and raise awareness of Supported Decision-Making (SDM) as a legally recognised alternative to guardianship. She is a nationally recognised leader in disability services and advocacy, working to build more inclusive communities, advance rights, and promote self-determination and

empowerment for people with disabilities. She is also an author, a mother of six, and a captivating speaker. She holds an MSEd in Special Education and Transition from the University of Kansas.

### Claudi Camps García

Director of the Mental Health and Addictions Network of the Girona region (Institute of Health Assistance, IAS). Recipient of the 2016 Medal of Merit in Healthcare and the CatSalut award for the most innovative mental health initiative for the development of this network.



In 2013, following the "Refinement" study, the Girona network was recognised as one of the most efficient mental health networks in Europe. In 2022, WHO

Europe highlighted this network as an example of the "effective participation of users and caregivers in the organisation of mental health care at the local level." In 2023, the IAS, together with the Support-Girona Foundation, was awarded the Zero Project prizes, endorsed by the United Nations, for the creation of innovative solutions such as Espai Obert.



### Facundo Chávez Penillas

Human rights lawyer and advocate specializing in disabilities the rights. He has worked extensively with the Office of the United Nations High Commissioner for Human Rights (OHCHR), focusing on ensuring the inclusion of people with disabilities within international human rights frameworks. His work emphasises the need for states and organisations to adopt inclusive policies that respect the dignity and autonomy of people with disabilities.

He is known for his expertise in the intersection between disability and international human rights law and has contributed to the development of policy recommendations and guidelines supporting the implementation of the United Nations Convention on the Rights of Persons with Disabilities (CRPD). His advocacy work often highlights the importance of the right to live independently and in the community, as well as the need for broad social transformations towards inclusion and equality.

### Antoni Galiano Barajas

Director General of Personal Autonomy and Disability at the Department of Social Rights of the Generalitat of Catalonia since February 14, 2025. He holds a Law degree from the Autonomous University of Barcelona and a master's degree in Disability, Personal Autonomy, and Dependency Care from the International University Menéndez Pelayo. Before his appointment, he served as the legal head of the Municipal Institute for People with Disabilities of the Barcelona City Council, where he played a key role in developing models for early intervention, personal assistance, independent living, and universal accessibility.



### Cecilia Gómez-Salvago Sánchez

Member of the Spanish Bioethics Committee and Professor of Civil Law at the University of Seville. Judge at the Civil Chamber of the Provincial Court of Seville (1999-2003).

### Inma Gómez Sánchez

Technical Director of COCARMI (Catalonia). Social worker. Postgraduate studies in Conflict Resolution and in Couple and Family Therapy. Her professional career has been linked for 20 years to the social third sector and the social and solidarity economy. Among other roles, she has advised organisations for people with disabilities on their management and political advocacy at the local level, organised events, and facilitated various working groups and participatory spaces.

She has coordinated and authored reports on rights violations and materials on rights advocacy in the field of disability. She is a member of various political and third-sector participation bodies. She has extensive experience as a trainer in the associative sector, citizen participation, rights advocacy, mutual aid groups, and social support groups.





### Natalia Kazah Soneyra

Clinical psychologist at the Specialized Hospitalization Unit for Intellectual Disability (UHEDI) at Parc Sanitari Sant Joan de Déu.

Specialist in Clinical Psychology accredited by the Government of the City of Buenos Aires and a postgraduate in Humanities from the University of Barce-Iona. She has been part of the Carlos III Health Institute's project "POMO-NA-SPAIN: Health Indicators for the Population with Intellectual Disability," as well

as four lifelong learning programmes of the European Union: Grundtvig (2008-2009 and 2010-2011) and Erasmus Plus (2015-2017 and 2019-2020) for people with intellectual disabilities. For the past 19 years, she has worked in an inpatient unit specialising in people with Intellectual Disabilities and associated Mental Health issues. Since 2023, she has coordinated the Ethics and Intellectual Disability Commission, which operates under the Clinical Ethics Committee of Parc Sanitari Sant Joan de Déu.

### Núria Martínez Barderi

Director of the Drissa Foundation, an organisation based in Girona dedicated to employment inclusion and improving the quality of life of people with mental health conditions. Under her leadership, the foundation has developed innovative projects in the fields of mental health, social economy, and sustainability, collaborating with public and private entities to promote the social and professional inclusion of people with mental health conditions.



In addition to leading local projects, the Drissa Foundation is also actively involved in international networks such as Social Firms Europe, advocating for mental health at a European level.



### Tina Minkowitz

Human Rights lawyer specialising in the CRPD and a survivor of psychiatric institutionalisation. She actively participated in drafting the Convention on the Rights of Persons with Disabilities (CRPD) and continues to contribute to its interpretation and implementation.

She is the founder and president of the Centre for the Human Rights of Users and Survivors of Psychiatry (www.chrusp.org). In 2024, she received the Ketil Njaa

### Victòria Monell Renart

Managing Director of the Fundació Malalts Mentals de Catalunya and President of Associació Encaix. She holds a degree in Business Administration and Management and an MBA from ESADE.

With 15 years of experience in financial and economic management in business, in 2009 she redirected her professional career towards the disability sector and non-profit organisations. She is a member of the Social Sector

Committee of the Coordinadora Catalana de Fundacions, board member of the FUTUPEMA association, a member of the International Guardianship Network, and board member of Fòrum Salut Mental i Addiccions. In the field of advocating for the rights of people with mental health disorders, she is a speaker in various forums and a lecturer in the Master's in Community Mental Health at the University of Barcelona.
